APPLICATION TO DETERMINE HEIRSHIP

NOTICE ISSUED

COMES NOW JPMorgan Chase Bank, N.A. ("Applicant"), a national bank with offices located at 2200 Ross Avenue, 7th Floor, Dallas, Texas 75201, and files this Application to Determine Heirship (the "Application") concerning the Estate of Max D. Hopper, deceased (the "Estate"), and for purposes of establishing the identity of all distributees of the Estate for purposes of the proof required under Section 145(d) of the Texas Probate Code, respectfully shows the Court as follows:

1. Max D. Hopper (the "Decedent") died on January 25, 2010 in Dallas, Dallas County, Texas.
2. An Application for Independent Administration of this Estate Pursuant to Texas Probate Code § 145(e) and for Waiver of Bond Pursuant to § 145(p) has been filed in Cause No. PR10-1517-3, and it is necessary and in the best interest of the Estate for the Court to determine who are the heirs, and only heirs, of Decedent.
3. Applicant asserts that the names and residences of all of Decedent's heirs, the relationship of each heir to Decedent, and the true interest of the Applicant and of each of the heirs in the Estate of Decedent are as follows:

Hopper; one-third (1/3) of the Separate Real Property of Max D. Hopper; and one-half (1/2) of a one-third (1/3) remainder interest in the Separate Real Property of Max D. Hopper.
- b. STEPHEN HOPPER
Age: 53 years (Born 11/21/56 at Fort Belvoir, Virginia)
Marital Status: Married
Address: 501 NW 41st Street, Oklahoma City, Oklahoma 73118
Relation: Son of Decedent
Interest: One-fourth (1/4) of the Community Estate of Max D. Hopper and Jo N. Hopper; one-third (1/3) of the Separate Personal Property of Max D. Hopper; one-third (1/3) of the Separate Real Property of Max D. Hopper; and one-half (1/2) of a one-third (1/3) remainder interest in Separate Real Property of Max D. Hopper.
- c. JO N. HOPPER
Age: 62 years (Born 05/14/47 at Nashville, Tennessee)
Marital Status: Widow
Address: 9 Robledo Drive, Dallas, Texas 75230
Relation: Surviving Wife of Decedent
Interest: One-half (1/2) of the Community Estate of Max D. Hopper and Jo N. Hopper; one-third (1/3) of the Separate Personal Property of Max D. Hopper; and a one-third (1/3) life estate in the Separate Real Property of Max D. Hopper.

4. Only two children, designated above, were born to or adopted by Decedent.


5. The Decedent was married two times. The Decedent married Marilyn J. Hickethier, and that marriage was terminated by divorce in 1978. Decedent married Jo N. McClendon Hopper, and that marriage was terminated by the death of Decedent. There were no other marriages of the Decedent that were ever dissolved, whether by divorce, annulment, or a declaration that the marriage was void.

6. At the time of his death, the Decedent was seized and possessed of real and personal property generally described as cash, securities, real property and personal effects situated in Dallas County, Texas of a value in excess of One Hundred Thousand Dollars.

WHEREFORE, Applicant prays that citation be issued as required by law to all persons interested in this Estate; that an attorney ad litem be appointed to represent Decedent's living heirs whose names and whereabouts are unknown; that upon hearing hereof, this Court determine who are the heirs and only heirs of Decedent and their respective shares and interests in this Estate.




