DEFENDANTS' THIRD AMENDED ANSWER, SPECIAL EXCEPTIONS TO PLAINTIFF'S FIRST AMENDED ORIGINAL PETITION AND COUNTERCLAIM FOR PARTITION OF PERSONAL PROPERTY OR PROCEEDS FROM SALE

Defendants and Counter-Plaintiffs Laura S. Wassmer and Stephen B. Hopper file this their Third Amended Answer and Special Exceptions to Plaintiff's First Amended Original Petition (the "Amended Petition") and Counterclaim for Partition of Personal Property or Proceeds from Sale, and in support thereof would respectfully show the Court the following:

I. GENERAL DENIAL

1. Pursuant to Rule 92 of the Texas Rules of Civil Procedure, Defendants hereby generally deny every allegation in Plaintiff's Amended Petition. Defendants demand strict proof of every allegation set forth in Plaintiff's Amended Petition, and any supplement or amendment thereto, by a preponderance of the evidence or by clear and convincing evidence in accordance with the applicable standards of proof.

II. AFFIRMATIVE DEFENSES

- 2. Defendants assert that Plaintiff's claims and allegations as set forth in her Amended Petition are barred by Plaintiff's unclean hands.
- 3. Defendants assert that Plaintiff's claims and allegations as set forth in her Amended Petition are barred by Plaintiff's failure to mitigate her damages.
- 4. Defendants assert that Plaintiff's claims and allegations as set forth in her Amended Petition are barred by estoppel and/or waiver.
- 5. Defendants assert that Plaintiff's claims and allegations as set forth in her Amended Petition with respect to breach of contract are barred because no such contract exists between Plaintiff and the Defendants.
- 6. If either Defendant is found liable for exemplary damages, those damages must be capped under Texas law and the Texas and U.S. Constitutions.
- 7. The imposition of exemplary damages here would violate Defendants' rights under the Texas and U.S. Constitutions.

III. SPECIAL EXCEPTIONS

- 8. Defendants specially except to Plaintiff's Amended Petition, paragraphs no. IV.C, IV.D, IV.G, and asks the Court to require Plaintiff to specify the maximum amount of damages that Plaintiff claims.
- 9. Defendants specially except to Plaintiff's Amended Petition because the pleadings ask for attorney fees in paragraph no. V.B with respect to Plaintiff's "other causes of action" but do not specify which statute makes them available in this type of suit.

- 10. Defendants specially except to Plaintiff's Amended Petition, Section IV—Count 1: Breach of Contract, because Plaintiff did not plead all elements of her cause of action for breach of contract. Specifically, the pleadings for breach of contract did not include the following elements: (a) that there is a valid, enforceable contract (*see, e.g., Petras v. Criswell*, 248 S.W.3d 471, 477 (Tex.App.—Dallas 2008, no pet.)); (b) that Plaintiff is a proper party to sue for breach of such contract (*see, e.g., Foley v. Daniel*, 346 S.W.3d 687, 690 (Tex.App.—El Paso 2009, no pet.)); and (c) that Plaintiff performed, tendered performance of, or was excused from performing its contractual obligations (*see, e.g., Foley*, 346 S.W.3d at 690).
- 11. Defendants specially except to Plaintiff's Amended Petition, Section IV—Count 2: Specific Performance, because such section sets forth merely a remedy and not a cause of action recognizable under Texas law.
- 12. For these reasons, Defendants ask the Court to set their special exceptions for hearing and, after the hearing, sustain their special exceptions and order Plaintiff to replead and cure her pleading defects and, if Plaintiff does not cure her defects, strike Plaintiff's pleading.

IV. COUNTERCLAIM FOR PARTITION OF PERSONAL PROPERTY OR PROCEEDS FROM SALE

Discovery Control Plan

13. Discovery in this matter is to be conducted under Level 3, pursuant to Texas Rule of Civil Procedure 190.4.

Parties

14. Defendant and Counter-Plaintiff Laura S. Wassmer is an individual not residing in Texas, but has entered an appearance in this case through counsel.

- 15. Defendant and Counter-Plaintiff Stephen B. Hopper is an individual not residing in Texas, but has entered an appearance in this case through counsel.
- 16. Plaintiff and Counter-Defendant Jo N. Hopper is an individual residing in Dallas County, Texas. Service is not necessary on Plaintiff/Counter-Defendant because she has entered an appearance in this case through her counsel.

Jurisdiction and Venue

- 17. This Court has subject matter jurisdiction over this counterclaim pursuant to Tex. Prop. Code § 23.001, *et seq.*, and because the damages sought by Counter-Plaintiffs are within the jurisdictional limits of the Court.
- 18. The Court has personal jurisdiction over the Plaintiff/Counter-Defendant because she is a resident of the State of Texas and has agreed to jurisdiction of this Court by filing her original claims in this Court.
- 19. Venue of these counterclaims is proper in Dallas County, Texas, because the property subject to the lawsuit is located in Dallas County, Texas, and because the counterclaims arise from the same set of underlying facts as the claims forming the basis of Plaintiff's Amended Petition.

Factual Background

20. Each Defendant is the owner of an undivided ¼ interest in the personal property listed on Exhibit 1 attached hereto. Plaintiff is the owner of an undivided ½ interest in such personal property. Such personal property was conveyed to Plaintiff and Defendants on February 2, 2015 pursuant to that certain *Independent Administrator's Assignment of Household Furnishings, Jewelry and Personal Effects* attached hereto as Exhibit 2, that certain *Independent*

Administrator's Assignment of Art attached hereto as Exhibit 3, and that certain Independent Administrator's Assignment – 5000 Shares of Pointserve, Inc. attached hereto as Exhibit 4.

21. Such personal property is the sole property of Plaintiff and Defendants and is held in undivided interests among them. Such personal property is not subject to the jurisdiction of any other court or part of any probate proceeding.

COUNT 1: Suit for Partition or, in the Alternative, for Sale of Property

- 22. The factual allegations set forth in paragraphs 13-21 are incorporated by reference as if fully set forth herein.
- 23. Defendants seek a partition of the personal property set forth on Exhibit 1 attached hereto. Alternatively, if the Court does not find a fair and equitable partition of such personal property can be made in kind, Defendants seek a sale of such personal property by order of the Court and the distribution of the net proceeds of any such sale be provided ¼ to each Defendant/Counter-Plaintiff and ½ to Plaintiff/Counter-Defendant.

Prayer

WHEREFORE, Defendants/Counter-Plaintiffs Laura S. Wassmer and Stephen B. Hopper request that Plaintiff/Counter-Defendant take nothing on her claims and that, upon final hearing, Defendants/Counter-Plaintiffs have judgment against Plaintiff/Counter-Defendant that:

- A. Confirms the value of the personal property set forth on Exhibit 1 attached hereto, and determines whether a fair and equitable partition of such property can be made and, if so, makes an allotment in kind of ½ of such property to each Defendant/Counter-Plaintiff and ½ of such property to Plaintiff/Counter-Defendant;
- B. Alternatively, in the event the Court determines that a fair and equitable partition of such property cannot be made in kind, orders that such property be sold according to

- the law and the proceeds of the sale, after expense of sale, be distributed ¼ to each Defendant/Counter-Plaintiff and ½ to Plaintiff/Counter-Defendant;
- C. Awards any actual damages, along with pre- and post-judgment interest, to
 Defendants/Counter-Plaintiffs;
- D. Awards to Defendants/Counter-Plaintiffs reasonable and necessary attorneys' fees and costs;
- E. Awards to Defendants/Counter-Plaintiffs all costs of court; and
- F. Awards to Defendants/Counter-Plaintiffs all other relief to which Defendants/Counter-Plaintiffs may be entitled.
